Notice For Expression of Interest Dated: 6th March, 2017

Expression of Interest is invited from the willing Registered Fishing Boat owners of Agatti Island to undertake Sports Fishing Activities in Lakshadweep waters under the aegis of SPORTS. A Roster of the boat owners will be maintained at the office of the Assistant General Manager, SPORTS Unit, Agatti based on the EOI received by the SPORTS on first come first serve basis. The last date for submitting the EOI to the office of the Assistant General Manager, SPORTS Unit, Agatti is 20.03.2017. The interested boat owners have to enter into an agreement with the SPORTS immediately after the finalization of the said Roster. In case, there is need to hire fishing boats before the finalization of the said Roster then the boats will be hired from the available EOI on first come first serve basis on the said particular day.

The interested boat owners must fulfill following conditions before submitting the EOI to SPORTS.

- 1. The LOA of the boat must be 40 feet or above and boat should not have canopy.
- 2. The boat should have the DAT, Radio VHF set for radio communication, AC current, Inverter, Toilet, Ladder and Drinking water.
- 3. The boat must have minimum number of Life Saving Equipments like Life Jackets, Life Buoys etc. based on the passenger capacity of the boat.
- 4. The boat must have Three (3) crew members and one (1) cook with fishermen ID.
- 5. The boat should be registered with the Fisheries Department as per the Lakshadweep Marine Fishing Regulation 2000 and the rules thereon and should have valid license from the Director of Fisheries or Authorized Officer.
- 6. The trip will be ex-Agatti and end at Agatti.
- 7. The timing for the said activities will be 6.30 am to 6.00 pm.
- 8. The charges for the engagement of boat will be decided at the time of entering agreement with the SPORTS.
- 9. The boat owner should maintain the boat neat and clean and readily available as and when asked for.

- 10. The boat owners are required to submit an undertaking to the effect that it will be the boat owner's responsibility for any damage to the boat and SPORTS will have no obligation in this respect what so ever.
- 11. The boat owners will not sub-contract the hiring of boat.

The interested Boat owners of Agatti Island complying with the above mandatory requirement and terms & conditions may submit their EOI and other documents to the Assistant General Manager, SPORTS Unit, Agatti on and before 20.03.2017.
