7. Quotation must be accompanied by EMD in the form of DD drawn in favour of General Manager, SPORTS, Kavaratti payable at Syndicate Bank, Kavaratti.

9. The successful bidder has to submit performance security for an amount equivalent of five percent of the value of contract in the form of an account payee Demand Draft or Bank Guarantee valid for one year.
